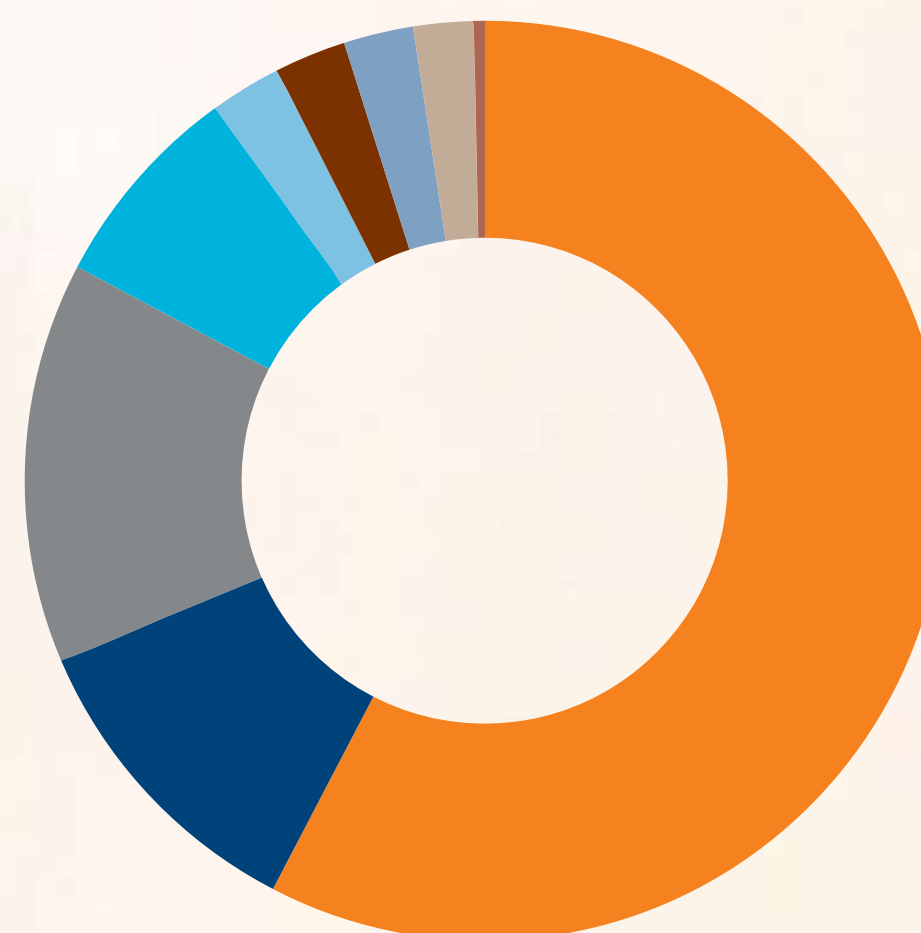

Key Points with Respect to Documentation

- Documents should be issued within the last 6 months

- Accredited Certificates issued by CDSL or NDML are not applicable
- For calculating New Worth Value of Self Occupied residence is not Considered
- Demand and time deposits with banks and financial institutions in IFSC, India or in any foreign jurisdiction, wherein the value of these deposits shall be considered to be lower of the actual value or USD 100,000

E.g. Saving Ac / Current Ac, Fixed Deposit, Recurring Deposit etc.
- ITR doesn't need to be certified and verified by Chartered Accountant

Key Points with Respect to Declaration

- Individual/Company/Partnership/Body Corporate is not resident of India under the Income-tax Act, 1961 ('the Act') and is not filing its income tax returns in India as resident of India and shall continue to be non-resident of India for the current financial year under the provisions of the Act.

As part of the Investment process, structured meetings are done with the Global X Teams. From USA , Canada & HK. Based on the opinion/outlook of the Teams, the underlying potential investments will be evaluated by the Local Team.

Guardrails of Allocation:

- The Thematic allocation will be 50%-70% in , while Country allocation of 30%-50% Developed Markets and Select Emerging Market
- For Thematic allocation, the underlying potential investments will be reviewed on various parameters including but not limited to the below:
 - Structural Journey of the theme (across segment based on market condition/valuation)
 - Long term growth potential
 - Diversification through growing global themes
- For Country allocation, weightage of the countries in the global market capitalization will be reviewed and proportionate exposure to be taken.
